ANNUAL MEETING/VOTE
LAKE REGION UNION ELEMENTARY-MIDDLE SCHOOL DISTRICT
Monday, March 8, 2021

The legal voters of the Lake Region Union Elementary-Middle School District (the “District”), comprising the towns of Albany, Barton, Brownington, Glover, Irasburg and Westmore, are hereby notified and warned to meet in their respective towns at the polling places hereinafter named between the hours of 10:00am and 7:00pm on Monday, March 8, 2021, to vote by Australian ballot on the following Articles.

- Article 1: To elect a moderator for the term ending at the 2022 Annual Meeting.
- Article 2: To elect a clerk for the term ending at the 2022 Annual Meeting.
- Article 3: To elect a treasurer for the term ending at the 2022 Annual Meeting.
- Article 4: Shall the voters approve the reports of the Lake Region Union Elementary-Middle School District officers as printed in the Annual Report of the District?
- Article 5: To elect school directors from the legal voters of said District for the following terms of office:
- A. School director from Albany for a term of three years.
 - B. School director from Brownington for a term of three years.
 - C. School director from Glover for a term of three years.
 - D. School director from within the boundaries of the former Orleans Incorporated School District for a term of three years.
 - E. School director from Westmore for a term of three years.
- Article 6: To elect school directors to the Lake Region Union High School District for the following terms of office:
- A. School director from Irasburg for the Lake Region Union High School District for a term of three years.
 - B. School director from Brownington for the Lake Region Union High School District for a term of three years.
 - C. School director from within the boundaries of the former Barton Incorporated School District for the Lake Region Union High School District for a term of three years.
 - D. School director from within the boundaries of the former Orleans Incorporated School District for the Lake Region Union High School District for a term of three years.

Article 7: To see if voters will authorize payment to the members of the board as follows:
A. Chair of the Board - \$2500
B. Clerk of the Board - \$1700
C. Vice Chair of the Board - \$1400
D. All other Board members - \$1300

Article 8: Shall the voters, pursuant to 16 V.S.A Section 567, authorize a transfer of Two Hundred Thousand Dollars (\$200,000) from the prior year audited fund balance to the capital reserve fund, pursuant to the provisions of 24 V.S.A. Section 2804, such funds to be used for repair, replacement and/or upgrading of structural components or operating systems of the buildings and grounds owned by the Lake Region Union Elementary-Middle School District, if such repair, replacement, and/or upgrading entails a projected cost in excess of Ten Thousand Dollars (\$10,000).

Article 9: Shall the voters authorize the Board of School Directors to expend \$12,705,418, which is the amount the school board has determined to be necessary for the ensuing fiscal year beginning July 1, 2021?

Article 10: Shall the voters authorize the Board of School Directors to borrow money to pay indebtedness and current expenses of the District?

Article 11: Shall the 2022 Annual School District Meeting be held on Monday, March 7, 2022?
