News from Annual Meeting: Substance abuse was brought up at the annual meeting as a potentially unmet need in our school. Glover has a 3 day guidance counselor and contract for two other days (EST and IEP). Substance abuse counselling is available. The speaker from last year for 5th-8th was too much for some students. Currently trying to handle on individual

student basis. First Aid and CPR training may help get children used to EMT and police personnel.

Community Eligibility Program: At last executive meeting was discussed. Glover and LR do not meet cut off for community lunch availability. If all schools were combined, now all schools would qualify but individual school reimbursement would decrease.
